### QUALIFICATIONS FOR OFFICE

To qualify to be nominated, elected and to hold office as a member of local government, a person **must** be:

- 18 years of age or older on General Voting Day (October 15);
- a Canadian citizen;
- a resident of BC for at least 6 months immediately before the day nomination papers are filed; and
- not disqualified by the *Local Government Act* or any other enactment from voting in an election in BC or from being nominated for, being elected to, or holding office, or be otherwise disqualified by law.

**Mayor and Candidates-at-large** must be nominated in writing by two (2) persons who are qualified electors of the District of Lake Country.

**Neighbourhood constituency candidates** must be nominated in writing by two (2) persons who are qualified electors of the neighbourhood constituency area in question.

- a resident of BC for at least 6 months immediately before the date of filing nomination papers; and
- not disqualified by the *Local Government Act*, *School Act*, or any other enactment from voting in an election in BC or from being nominated for, being elected to, or holding office, or be otherwise disqualified by law.

School Trustee candidates must be nominated in writing by two (2) persons who are qualified electors of School District Zone I for which the person is nominated.

A \$100 deposit, in the form of a cheque written to School District 23, is required.
