Date

As of February 1, 2021, legislation was introduced by the Provincial government requiring all local governments to participate in the Contaminated Site Identification process. The site identification process is intended to screen for contaminated sites to protect the environment, potential property purchasers, and to prevent unforeseen liabilities. The provincial Contaminated Sites Regulation requires that any person making an application for site development must submit a Site Disclosure Statement (SDS) to the municipality, identifying any Schedule 2 activities that have taken, or are taking, place on the site. It is most often triggered when a regulated industrial or commercial activity stops or when a site is to be redeveloped and requires approvals from the District. The intention is to ensure investigation and remediation of contaminated site occurs before redevelopment.
