A BYLAW TO DISCHARGE LAND USE CONTRACT NO. 207

WHEREAS by Regional District of Central Okanagan Land Use Contract Bylaw No. 207, was adopted January 9, 1979 (hereinafter called "Land Use Contract No. 207");

The Mayor and Corporate Officer are hereby authorized to sign any conveyances, deeds, receipts or other documents in connection with the discharge of Land Use Contract No. 207 from Lot 1 Sec. 16, Twp. 20 ODYD Plan KAP71457, Lot 2 Sec. 16, Twp. 20 ODYD Plan KAP71457, Lot 3 Sec. 16, Twp. 20 ODYD Plan KAP71457 and Lot 4 Sec. 16, Twp. 20 ODYD Plan KAP71457.
- 3. This bylaw may be cited as "Lake Country Land Use Contract Discharge (Barsi) Bylaw 779, 2010".
