**BYLAW 1083**

**A BYLAW TO AMEND OFFICIAL COMMUNITY PLAN BYLAW 1065, 2018**

---

**NOW THEREFORE**, the Council of the District of Lake Country, in open meeting assembled, enacts as follows:

- 1) The District of Lake Country Official Community Plan Bylaw 1065, 2018 is hereby amended by changing Map 1 - Future Land Use Plan and the associated land use designation of:

A portion of That Part of the Fractional South East  $\frac{1}{4}$  of Section 11 Outlined Red on Plan B3779; Township 14 ODYD Except: (1) Colored Red on Plan A421 (2) Plans 8939 and 39746

**From:** Tourist Commercial

**To:** Agricultural

As shown on Schedule "A" as Area 'A' which is attached hereto.

**From:** Agricultural

**To:** Tourist Commercial

As shown on Schedule "A" as Area 'B' which is attached hereto.

- 2) The District of Lake Country Official Community Plan Bylaw 1065, 2018 is hereby amended by changing Map 3 – Urban Containment Boundary to include:

A portion of That Part of the Fractional South East  $\frac{1}{4}$  of Section 11 Outlined Red on Plan B3779; Township 14 ODYD Except: (1) Colored Red on Plan A421 (2) Plans 8939 and 39746

As shown on Schedule "A" as Area 'B' which is attached hereto.

- 3) This Bylaw may be cited as "Official Community Plan Amendment (OCP2018-002) Bylaw 1083, 2019".

READ A FIRST TIME this 2<sup>nd</sup> day of July, 2019.

READ A SECOND TIME as amended this 2<sup>nd</sup> day of March 2021.

ADVERTISED on the 29<sup>th</sup> day of April and 6<sup>th</sup> day of May, 2021 and a Public Hearing held pursuant to the provisions of Section 464 of the *Local Government Act* on the 11<sup>th</sup> day of May, 2021.

READ A THIRD TIME this 1<sup>st</sup> day of June, 2021.

ADOPTED this 6<sup>th</sup> day of July, 2021.
