I/We, having applied to the District for a water and/or sewer service connection and agree to comply with all the applicable District Bylaws, Regulations and Policies as amended from time to time. **Water users** are advised that all services shall have a pressure-reducing valve installed, including the installation of vacuum breakers and backflow prevention devices in accordance with the B.C. Plumbing Code. The District will not be responsible for any damage caused by high pressure or back-syphoning.

I have read and understand the above:

I/We are also aware the **pressure** may not be adequate, and it will be my/our responsibility to provide and maintain any pumps and/or pressure tanks and a testable backflow preventor device acceptable to the District to provide adequate pressure for this service.

The applicant agrees to a sum of money to cover all costs of installation prior to commencement of work and further agrees to pay all costs of connection performed and/or material supplied by the District.

**NOTE**: Billing of services for new construction will commence no later than three months following the date of building permit issuance OR when the water is turned on by the District, whichever is sooner. Billing of services for existing residences will commence the first day of the month following the date of building permit issuance.

**IMPORTANT**: The District Building Inspector or Engineering Department must be notified of inspection for water/and or sewer services before backfilling takes place. Phone 766-6676. **Note**: 48 hours notice required for inspection.
